## Bids invited for complete job of Event Production and Management for Taj Mahotsav-2017

Bids are invited by the Taj Mahotsav Samiti, 64, Taj Road, Agra for its forthcoming event Taj Mahotsav-2017, scheduled to be organized from **18<sup>th</sup> to 27<sup>th</sup> March, 2017** at Shilpgram, Near - Taj Mahal Eastern Gate, Agra for a complete job of Event Production and Management on hire basis which include all related works as described hereunder :-

Complete works of stage lights, sound & PA system, proper lighting of the whole venue, electric decoration of venue, entry gate, all tentage works like-sofa, chairs, table, barricading, erection of shilpi stalls, food courts, commercial stalls, stage decoration based on Theme **"fojklr dh Nkjo esa"**, Videography, Photography, cleaning arrangements, mobile toilets, erection of offices for medical camp, water supply, sanitation, horticulture, electricity etc. erection of reception and enquiry counter, ticket counters, Police Station/ CCTV control room, camp office of chairman/ VIP, fire station, Signages, DFMD/CCTV/ CC Camera etc., walky-talky, security personnel, onsite branding & Taj Mahotsav theme based interior decoration of the venue, silent generator sets (AVR system) of 125 KV, on rental basis.

This Bid shall be in two parts, i.e., **Part-A Technical Bid** and **Part-B Financial Bid**. Two separate sealed envelopes must be used for the technical and financial bids separately and marked accordingly and these two sealed envelopes should be kept in one sealed cover marked accordingly. **Financial bids shall be opened only if the bidder qualifies in the Technical bid & Audio-Video Presentation.** 

#### THE TECHNICAL BID SHOULD NECESSARILY HAVE THE FOLLOWING QUALIFICATIONS AND SUPPORTING DOCUMENTS ATTACHED WITH THE BID:-

- 1- The Bidder should have a valid ISO certification.
- 2- The Bid must have a Demand Draft or FD of Rs. 5.00 Lakhs duly pledged in favour of "Secretary, Taj Mahotsav Samiti, Agra"
- 3- Service Tax Registration Number.
- 4- Income Tax PAN No.
- 5- Copies of the Income Tax Returns of last three consecutive years are to be attached.
- 6- The Bidder shall have to furnish on a separate sheet the details of doing such works in last three years along with year-wise break-up. (**Documentary proof must be attached**).
- 7- The successful bidders in the technical round shall be required to make an audio-Video presentation of their past profile, experience & conceptual plan for Taj Mahotsav-2017 before the selection committee at Agra on the date so intimated by the organizing committee. Decision of the committee shall be final.

(i) The maximum time for presentation of the past works done by them and conceptual plan for Taj Mahotsav-2017 shall be 25 minutes. Hard copy along with a soft copy of presentation shall have to be provided to the Taj Mahotsav Comittee at the time of presentation.

- (ii) Agencies are requested to be prepared to give the presentation on a short notice.
- 8- The Bidder shall have to attach proof of financial status of the company indicating total turnover for the last three years (Audited reports to be attached)

#### COMPULSORY TERMS AND CONDITIONS FOR BIDDING FOR TAJ MAHOTSAV (<u>18<sup>TH</sup> TO 27<sup>TH</sup> March 2017</u>)

- 9- Partial bidding or conditional bidding shall not be allowed. Bidder shall submit at least THREE designs/ photographs of (1). Stage decoration work, (2). Theme based Interior decoration (statue, mask, wall painting etc.) and (3). Sofa sets, chairs and matting/ carpeting work.
- 10-The use of any inflammatory material is compulsorily prohibited in the making of such temporary structures. All production works for the technical and entertainment areas in the venue must adhere to the safety specifications/ requirements as per the prevailing rules and regulations.
- 11-First aid fire fighting systems (like Co<sub>2</sub> type, ABC type etc) at different places should be provided by the Bidder as per IS 2190 :1992 inside whole premises.
- 12- The cables for the lighting arrangements and decorative lights shall be laid underground with adequate attention provided towards its safety. The Bidder should possess an appropriate license for doing such works. The Bidder shall be responsible for obtaining clearance certificate from the Electric Safety Department for doing such works at the Mela Venue.
- 13-Each and every component of the production work for the technical and entertainment areas must be able to sustain a wind load of 100 kmph.

- 14- The Supervisor, employees and the labour who would be working at the site must have separate uniforms for enabling their identification.
- 15-The trial of the event will be held three days prior to the beginning of the event. The bidder must complete all works in all respects by that time-frame, otherwise the Organizing Committee shall have the right to forfeit the security money and all materials on the site to get it done by any other appropriate agency.
- 16-It will be obligatory on the part of the bidder to sign an agreement with the Competent Authority of the organizing committee for timely completion of all works in a satisfactory manner.
- 17- The organizing committee shall not be responsible for any compensation to the bidder in case of any accident/ natural calamity/ fire or any other loss whatsoever occurred to the bidder. It shall be obligatory on the part of the bidder to make proper insurances of all structures and manpower.
- 18- The bidders are advised to visit the venue of the event before quoting their rates. The work dimensions mentioned in the tender document may vary. The quantity mentioned in the tender document can be increased or decreased on site as per actual requirement and shall need to be supplied by the bidder.
- 19-In case of any dispute, the courts of law situated at District Agra, Uttar Pradesh, shall have requisite jurisdiction.
- 20- The organizing committee shall have the right to reject any bid/ tender without assigning any reason and its decision shall be final and binding on all the bidder(s).
- 21- The financial bid shall be finalized on the basis of total value of the bid.
- 22- After finalization of work order, if party denies to do the work, the security money will be forfeited and legal actions shall be done against the party.
