Bids are invited by the Taj Mahotsav Samiti, 64, Taj Road, Agra for its forthcoming event Taj Mahotsav-2012, scheduled to be organized from 16th to 25rd March, 2012 at Shilp Gram, Near- Taj Mahal Eastern Gate, Agra for a complete job of Event Production and Management on hire basis which includes all related works as described hereunder:-

Complete works of stage lights, sound & PA system, proper lighting of the whole venue, electric decoration of venue, entry gates, all tentage works like-sofa, chairs, table, barricading, erection of shilpi stalls, food courts, commercial stalls, stage decoration in Bollywood style, mobile toilets, erection of offices for medical camp, water supply, sanitation, horticulture, electricity etc. erection of reception and enquiry counter, ticket counters, Police Station/ CCTV control room, camp office of chairman/ VIP, fire station, watch towers, Signages, DFMD/ CCTV/ CC Camera etc., walky-talky, security personnel, on-site branding & interior decoration of the venue, special arrangements for theme-based opening & closing ceremonies, supply of mementoes, arrangements for press conference & curtain raiser etc. manpower for ticket vending and checking at all entry gates, making of photo ID cards to all artisans and participants, silent generator sets (AVR system) of 125 KV on rental basis.

This Bid shall be in two parts, i.e., **Part-A Technical Bid** and **Part-B Financial Bid**. Two separate sealed envelopes must be used for the technical and financial bids separately and marked accordingly and these two sealed envelopes should be kept in one sealed cover marked accordingly. **Financial bids shall be opened only if the bidder qualifies in the Technical bid.**

The Technical Bid should necessarily have the following qualifications and supporting documents attached with the bid:-

- 1- The Bidder should have a valid ISO certification.
- 2- The Bid must have a Demand Draft or FD/ NSC of Rs. 5.00 Lakhs (Five Lakh) duly pledged in favour of “Secretary, Taj Mahotsav Samiti, Agra”
- 3- VAT/ Trade Tax Registration Number.
- 4- Service Tax Registration Number.
- 5- Income Tax PAN/TAN/TIN No.
- 6- Copies of the Income Tax Returns of last three consecutive years are to be attached.
- 7- The Bidder shall have to furnish on a separate sheet the details of doing such works in last three years along with year-wise break-up. (Documentary proof must be attached).
- 8- The Bidder shall have to attach proof of financial status of the company indicating total turnover for the last three years totaling an amount of at least Rs.3.00 crores. (Audited reports/ Balance Sheets to be attached).
- 9- **Along with the Bid document /tender form. downloaded from the website a demand draft of the required fees shall be enclosed with the Bid document / tender form in favour of “Secretary, Taj Mahotsav Samiti,” payable at Agra. The tender form without the requisite fees shall be cancelled.**

**COMPULSORY TERMS AND CONDITIONS FOR BIDDING FOR TAJ MAHOTSAV
(16th to 25th March, 2012)**

- 10- Partial bidding or conditional bidding shall not be allowed. Bidder shall submit at least **THREE designs/ photographs of** (1). Stage decoration work, (2). Theme based interior decoration/ on-site branding work, (3). Gate and (4). Sofa sets, chairs and matting/ carpeting works.
- 11- The use of any inflammatory material is compulsorily prohibited in the making of such temporary structures. The colour combination and the theme of all the production work for the technical and entertainment areas in the venue must adhere to the specifications/ requirements given by the organizers.
- 12- The cables for the lighting arrangements and decorative lights shall be laid underground with adequate attention provided towards its safety. The Bidder should possess an appropriate license for doing such works. The Bidder shall be responsible for obtaining clearance certificate from the Electric Safety Department for doing such works at the Mela Venue.
- 13- Each and every component of the production work for the technical and entertainment areas must be able to sustain a wind load of 100 kmph.
- 14- The Supervisor and the labour who would be working at the site must have separate uniforms for enabling their identification.
- 15- The trial of the event will be held three days prior to the beginning of the event. The bidder must complete all works in all respects by that time-frame, otherwise the Organizing Committee shall have the right to forfeit the security money and all materials on the site to get it done by any other appropriate agency.
- 16- It will be obligatory on the part of the bidder to sign an agreement with the Competent Authority of the organizing committee for timely completion of all works in a satisfactory manner.
- 17- The organizing committee shall not be responsible for any compensation to the bidder in case of any accident/ natural calamity/ fire or any other loss whatsoever occurred to the bidder. It shall be obligatory on the part of the bidder to make proper insurances of all structures and manpower.
- 18- The bidders are advised to visit the venue of the event before quoting their rates. The work dimensions mentioned in the tender document may vary, the payment for which shall be made on pro rata basis. The quantity mentioned in the tender document can be increased or decreased on site as per actual requirement and shall need to be supplied by the bidder. No extra payment will be made to the bidder if the period of the event is extended.
- 19- In case of any dispute, the courts of law situated at District Agra, Uttar Pradesh, shall have requisite jurisdiction.
- 20- The organizing committee shall have the right to reject any bid/ tender without assigning any reason and its decision shall be final and binding on all the bidder(s).
- 21- The financial bid shall be finalized on the basis of total value of the bid.
